Legal and supportive services: The Make The Road family of organizations offers a wide range of legal and support services. Make the Road New Jersey's legal services department offers high-quality pro bono legal representation in immigration law. It also provides representation in employment law matters and host a COVID relief legal clinic. Its health advocates and promotor as reach thousands of immigrant families to help connect them with health insurance each year.
