TODAY, THE GLOBAL NGO RUNS 250 SCHOOLS ACROSS COMMUNITIES IN NEPAL, CAMBODIA AND MYANMAR UNREACHED EVEN BY OTHER HIGH ACHIEVING NGOS. WITH A MODEL BASED ON AN UNWAVERING COMMITMENT TO QUALITY EDUCATION THAT ALWAYS MEETS OR EXCEEDS NATIONAL STANDARDS, AND A RELENTLESS PURSUIT OF COST EFFICIENCY THAT ALLOWS SCHOOLS TO BE BUILT AT AN AVERAGE COST OF LESS THAN \$40,000 AND OPERATED FOR LESS THAN \$2 PER WEEK PER CHILD; NO OTHER ORGANIZATION HAS PIONEERED SUCH A UNIQUE AND ACHIEVABLE VISION FOR BRINGING THE WORLDS OUT-OF-SCHOOL CHILDREN INTO CLASSROOMS.
