PancONE provided a research grant of \$50,000 to Stand Up to Cancer (SU2C) in support of the PASS-01 clinical trial. This trial brings together leading cancer research centres across North America to advance personalized medicine for pancreatic cancer patients. Using the patient's tumor cells, an organoid (a.k.a. a tumor "avatar") is created that researchers will test 100+ novel drug therapies on in a lab setting to determine which treatment will give the patient the greatest chance at a longer life.

PancONE provided a research grant of \$3,062 to American Friends of UHN Inc., in support of the study of slowing tumor growth in pancreatic cancer by cutting off cell communication.
