EACH OF THE CASES WAS FILED IN THE NEW MEXICO SECOND JUDICIAL DISTRICT COURT BY THE NEW MEXICO ENVIRONMENTAL LAW CENTER ON BEHALF OF THE CLIENTS LISTED ABOVE FOR EACH CASE. THE CASES WERE FILED AGAINST THE BERNALILLO COUNTY (NEW MEXICO) BOARD OF COUNTY COMMISSIONERS, THE INDIVIDUAL MEMBERS OF THE BOARD OF COUNTY COMMISSIONERS (COLLECTIVELY THE "BOARD") AND THE TWO COMPANIES PROMOTING THE PROPOSED DEVELOPMENT, CONSENSUS PLANNING, INC. AND WESTERN ALBUQUERQUE LAND HOLDINGS, LLC. IN CASE 3, THE NEW MEXICO SECOND JUDICIAL DISTRICT COURT AFFIRMED THE DECISION OF THE BOARD TO APPROVE THE SANTOLINA LEVEL B MASTER PLAN. THE NEW MEXICO ENVIRONMENTAL LAW CENTER'S CLIENTS APPEALED THE DECISION TO THE NEW MEXICO COURT OF APPEALS ON JANUARY 22, 2020. IN CASE 4, THE NEW MEXICO SECOND JUDICIAL DISTRICT COURT AFFIRMED THE DECISION OF THE BOARD TO APPROVE THE SANTOLINA LEVEL B DEVELOPMENT AGREEMENT, WHICH SERVES TO CODIFY AND IMPLEMENT THE SANTOLINA LEVEL B MASTER PLAN.
