Our mission is to eradicate the educational inequities that Black and other girls of color experience in k-12 education. We work alongside our girls as well as those who parent, care for, and mentor them to remove barriers that keep them from achieving their full potential. Together we freedom dream schools and communities that are more equitable and racially just.

Service include participation in fellowship opportunities, group restorative circles, and healing/mental health retreats.

Mentorship through professional development, conferencing, and cultural immersion travel - provide mentees with travel grants to attend conferences focused on college, career, leadership, and restorative justice development. Hosted mentors/mentees on 13-day cultural immersion trip to Ghana to develop self-efficacy, knowledge of history, and a sense of agency, voice, and self-pride, all of which contribute to a healthy mindset, self-esteem socio-emotional wellbeing, mental health, and positive school and life outcomes.

Sponsorships, Grants, & Offerings - OEF Microgrant program provided youth of color in need of financial support, and enrolled in local K-12 schools, with funding to access educational opportunities like after school programs, extracurriculars, SAT Prep, AP exams, college applications, etc. Also hosted 63 girls for celebratory end-of-program luncheon to honor them as grant recipients and their academic achievements. Provided service opportunities for girls enrolled in our mentor programs which included supporting girls and women impacted by intimate partner violence and houselessness.

Explanation: We are a minority owned, small, early start volunteer powered organization with limited funds and resources. As a first-generation business owner, we also lacked the human resources needed to complete the more comprehensive filing we learned we needed to make. To explain, we initially believed we would be filing a Form 990 Postcard due to not meeting the financial threshold to file form 990, however, after receiving two substantial grants at the end of the fiscal year in November 2022 and December 2022, we found ourselves surpassing the financial threshold for a postcard filing and in the position of needing to secure an accountant and bookkeeper to help organize financial records and prepare for a more comprehensive filing as required by law. This took a few months to organize and audit our records, at which time we filed a paper copy of the form 990. We wanted to make sure we accounted for all revenue and expenses accurately. We recently received that filing back and were informed by the IRS that we needed to e-file. Again, due to our early start status we were unaware of this requirement. We are now aware and have made the adjustments and hired the people we need to have on staff to help with future filings. Now that we have the financial infrastructure in place, it is your intention to make all future filings on time, and as required by the IRS. We think you for your consideration of our situation and request that you waive all late fees.
