WITH THE HELP OF OVER 3,000 MONTHLY VOLUNTEERS, THE F4F NETWORK DELIVERS OVER 20,000 MEALS TO FAMILIES EVERY MONTH AS WELL AS OTHER ESSENTIALS. THIS BREAKS DOWN TO OVER 2,600 FAMILIES, OR OVER 10,000 INDIVIDUALS, SERVED MONTHLY. TO DATE, THE FAMILIES4FAMILIES NETWORK HAS DELIVERED 884,058 MEALS TO FAMILIES IN NEED ACROSS THE COUNTRY.
