CORAZÓN-AZ is a multi-faith, multi-generational, and diverse community organization that is building organizing capacity in Arizona, organizing houses of worship, schools, and individuals who have shared core values. We trained 66 leaders and clergy and 105 youth on basic principles of organizing, Civic Engagement, and election protection. We are dedicated to Our Rise to Vote Arizona campaign 2022, to whole circle civic engagement. (Voter Registration and Education, turnout, and election protection) In total, we knocked over 43,000 doors, made over 143,000 calls, and sent over 110,000 texts. Our primary and general election protection programs were able to document several instances of voter engagement that needed to be captured, and we even diffused tense situations at polling locations.
