WE LED TWO CTC COALITIONS AND ENGAGED RACIAL JUSTICE GROUPS IN OUR WORK. WE SUCCEEDED IN EXPANDING REFUNDABLE TAX CREDITS IN STATES LIKE CA, IL, AND NJ, BRINGING RESOURCES, STRATEGY, AND TECHNICAL ASSISTANCE TO BUILD POWER AND MOMENTUM FOR CASH POLICIES.
