Through the launch of our State Climate Leadership Initiative, Evergreen Action supported state leaders in the 2022 midterm elections, made climate action a central issue of critical gubernatorial re-election campaigns and advised policymakers on the critical need to execute state level climate action to augment the historic investments provided by the Inflation Reduction Act.
