In 2022, Ashrei Foundation launched a pilot program to expand access to photo identification, which has now become an established program called the North City Photo ID Project. In 2022, this program trained 63 volunteers and served 199 individuals. We covered the costs of 84 Missouri birth certificates, 22 out-of-state birth certificates, and supported (through financial and/or logistical assistance) applications for 88 Missouri non-driver photo IDs. This program offered 3 volunteer training events, and monthly ID access days, open to the public. The North City Photo ID Project operates out of our office space in a community center called The Tabernacle Hub, located in North St. Louis City.
