WE HOSTED 25 CAMPERS, AGES 9 TO 15, WITH HEART CONDITIONS RANGING FROM COMPLEX CONGENITAL HEART SURGERY, PACEMAKERS FOR ARRHYTHMIA PROBLEMS AND PULMONARY HYPERTENSION. WE ALSO HOSTED FIVE COUNSELORS IN TRAINING, FORMER CAMPERS WHO ARE WORKING TOWARDS BEING FULL COUNSELORS. MORE THAN TWO DOZEN VOLUNTEERS HELPED MAKE THE CAMP RUN SMOOTHLY.
