PUBLIC OUTREACH EDUCATION. ERF, partially through grants to related organization WCAN, exceeded our yearly goals by having 18,093 conversations through the door-to-door canvass about our housing, mass liberation health care work. Mass liberation was a key focus of leaders in 2022, with leader led actions against the WA State Clemency Pardons Board, the Pierce County Prosecutor County Court to utilize a law passed in 2020 which created a new procedure for prosecutors to petition a sentencing court to resentence an individual previously convicted already sentenced for a felony if the original sentence no longer serves the interests of justice. Prosecutorial discretion in reducing sentencing is a big step to reduce mass incarceration. To raise awareness of the lack of prosecutors using this new procedure, we organized a direct action in Pierce County against Prosecutor Mary Robnett the County Court. 54 Tacoma based leaders attended the rally. cont. Sched O

LEADERSHIP DEVELOPMENT. ERF, partially through grants to related organization WCAN, developed more than 50 leaders to take deeper action with their leadership. The majority of these new leaders took multiple actions 3 throughout the year including attending events, leading conversations on issues directly impacting them and bringing community members to outreach events. Five leaders were mobilized to attend Universal Healthcare Cost Transparency Board meetings and the Universal Health Care Commission meetings to bring patients perspectives and experiences to those boards. Three new leaders were engaged to become spokespersons to educate about our healthcare work. In 2022 we surveyed our active leaders about the issues that were important to them and to evaluate the work being done. 147 people responded to the survey and their responses were used to shape the strategic planning process set to begin at the start of 2023.

Form 990, Part III, Line 4a	PUBLIC OUTREACH EDUCATION cont. They delivered a request to Pierce County Prosecutor Mary Robnett demanding that she be held accountable to the community and use the 6164 to resentence individuals whose sentences are not in the interest of justice. Community organizers held an education outreach event attended by 40 people, and held 23 one-on-one meetings with individuals about their loved ones eligibility for resentencing. One organizer served as court reporter for 3 resentencing hearings, and mobilized 13 community members to attend them. Action was also taken by leaders to hold the WA State Clemency and Pardons Board accountable with a leader published Op-Ed detailing the racist nature and practices of the board chair James McDevitt. Following this Op-Ed, a leader authored petition demanding his removal was started and 1,116 signatures were gathered in support. As a result of the mounting pressure, James McDevitt vacated the position and no longer serves on the board. The board replaced James McDevitt and a second vacant position with more racial justice minded people.

The Board Finance Committee then reviews the 990 and then forwards and presents to the full board of directors for approval. If any corrections are made in response to questions from general directors or from the Finance Committee, the final version is emailed to the Board before filing.

Determinations of whether a conflict exists, and the review of actual conflicts is made at the board level. After any discussion with the interested person, they shall leave the meeting while the Board discusses whether a conflict of interest exists.
