**28** This year we've been busy traveling throughout the reservation working on several different issues and meeting with everyone from schools to community activist groups to save Chaco Canyon and to preserve Native Foodways, and to teach language and mythology to youth in schools. At these events we have been doing food education for the early childhood level parents and students and participating in a lot of educating in Native Foodways preparation, collecting and enjoying healthy foods in different communities with the youth and early childhood students and their parents. places are Torreon ,New Mexico Piñon, Arizona, and Bluff, Utah where we have been doing a lot of our community education and we have a large cornfield where there is a big hogan that is used as an education center for the whole region of Black Mesa. At this particular place we also teach cultural crafts, food processing and folklore of the Navajo culture. Our educational Hogan structure that we are working on for Indigenous Cultural Concepts, which is located on the western side of the region. This training center is still being built; we are in the final stages of finishing this particular multipurpose structure. We went to Newcomb, New Mexico community school for the Earth Day activities, where we trained the school age kids from fifth grade to eighth grade about gardens, worms, compost, recycling and growing food and helping them identify water a catchment site from the school buildings to use in the new gardens -this was in April 2022. Over the course of the summer we have been taking youth on hiking, boating, swimming ,kayaking trips and educating them about plants that grow around the water and the different species that live in the water and how they reproduce, and how they contribute to the ecosystem in various areas of the Southwest in the rivers and lakes. In the fall we do work in the different communities with education about food preparation and wild foods, and also teach about animal food processing, where we harvest wild game to prepare for winter, and storage of food and seeds for renewal the next year. We also had a camping trip in Colorado to encourage used to enjoy outdoor life and experiment hiking, camping trail walking, zip lining, water safety and habitats. Also on this trip we talked about our cultural connection this region in the four Corners area. Names of places, plants, trees and animals. Our Water education included testing for contamination for heavy metals, uranium, arsenic, and others stuff that may be in the water that will have bad impacts such as a gold mine spill happened along the river which a lot of farmers grow their foods, luckily it's safe for now. There are a lot of sites that are being proposed for oil and gas wells to be developed. On this trip we have been practicing "leave no trace". Keeping the environment clean as before camping. So on our Navajo nation there's a lot of corrupt tribal government running the land sales program to multinational corporations which in turn destroys our way of life which depletes the environment of the natural balance and so this is what our work to educate the youth is about. We have been able to have monthly support group meetings, and support one another with shared resources, ideas, fundraising, training and organizing. WCLM has participated in various cultural events that support our communities, such as our local activists and their events. Our newly developed partnerships connect with both local and international organizations that focus on women of color and their empowerment and leadership. We have participated in workshops, cultural festivals, trainings and lectures, and have been able to send some of our members to these events. We have been able to support our members in leading their own workshops and presentations as well as supported them in their cultural artistic efforts. We have also been able to offer some support to students of at several of our local State Colleges, who were affected by the current racial tensions on campus, and in the community of Olympia. Some of our future goal are to bring more guest speakers, cultural trainings and workshops/ spokesperson and activist on racial issues, as well as women from our local Native tribes. These speakers would be able to address many of the issues around race, class, and gender, as well as the effects of colonization on Black and Brown peoples. We also hope to send a group of the women to conferences and workshops statewide and to able to make international connections as well to help foster their resiliency tools.
