Management recommends to the Board of directors a lump sum for salary increases as part of its budget recommendations and once approved, management distributes that lump sum among individuals based on its pay policy and the most recent salary comparability data. This same pay policy and salary comparability data is made available to the Board of directors to be used as a reference in its annual review of the Executive Director's compensation. The Executive Director's salary was not reviewed in 2020 or adjusted in 2020 but will be in 2021.
