RESEARCH:AFIDEP SEEKS TO PROVIDE EVIDENCE THAT HELPS DECISION-MAKERS IDENTIFY AND SCALE-UP INTERVENTIONS TO IMPROVE THE QUALITY AND REACH OF SOCIAL SERVICES, ESPECIALLY TO UNDER-SERVED POPULATIONS.
