PDFs Community Advised, Designated Grants and Donor Advised Funds bring donors, grassroots organizers and funders together for grantmaking and community building, strengthening relationships across sectors of the social justice movements. PDF Fiscal Sponsorship extends our mission and program; we sponsor on average 47 groups each year. With offices in California and Massachusetts, we offer all our programs to groups across the US, and fiscal sponsorship to those based in the US supporting international programs. 135 total grants were made.
