THE RIAN IMMIGRANT CENTER IS THE FISCAL SPONSOR OF THE MIC. IMMIGRANTS ARE THE BACKBONE OF SUPPORT FOR THE CITY OF BOSTON AND ITS SURROUNDING COMMUNITIES. MANY IMMIGRANTS WERE STRUCK BY LOSING THEIR JOBS AND HAVING LITTLE-TO-NO ACCESS TO BENEFITS OR HEALTHCARE.
