OUR CURRICULUM OFFERS ENGLISH FOR SPEAKERS OF OTHER LANGUAGES (ESOL), CITIZENSHIP TEST PREPARATION, HISET TEST PREPARATION, AND ADULT BASIC EDUCATION TO BETTER SERVE THE LARGE POPULATION OF IMMIGRANTS WHO LIVE AND WORK IN BERKSHIRE COUNTY. BY PROVIDING FUNDAMENTAL EDUCATIONAL SUPPORT, LITNET STRIVES TO GIVE OUR ADULT LEARNERS THE TOOLS THEY NEED TO SUCCEED IN THEIR JOBS, SUPPORT THEIR FAMILIES, AND ENGAGE WITH THEIR LOCAL COMMUNITIES. IN 2023, LITNET SERVED A TOTAL OF 330 LEARNERS IN ITS ONE-ON-ONE TUTORING PROGRAMS.
