ADVOCACY, OUTREACH AND RESEARCH ACTIVITIES:ADVOCACY- ACHA PLAYED A LEADING ROLE IN ADVOCATING FOR THE PASSAGE OF THE CONGENITAL HEART FUTURES ACT IN 2010 AS PART OF THE AFFORDABLE CARE ACT AND FOR THE CONGENITAL HEART FUTURES REAUTHORIZATION ACT (CHFRA) OF 2017. THIS LEGISLATION AUTHORIZES UP TO \$10 MILLION ANNUALLY IN FEDERAL FUNDING TO STUDY AND COLLECT DATA ON CONGENITAL HEART DISEASE THROUGH THE U.S. CENTERS FOR DISEASE CONTROL AND PREVENTION, AND IT DIRECTS THE NATIONAL INSTITUTES OF HEALTH TO REPORT ON ONGOING RESEARCH EFFORTS IN CHD.
