WE HIRE MEMBERS OF THE HOMELESS COMMUNITY TO TEND THE POTS, WHICH ARE PAINTED BY LOCAL ARTISTS. THE VEGETABLES ARE AVAILABLE FOR FREE TO ANYONE IN NEED, ADDRESSING HUNGER IN OUR CITY. EATS OF THE STREET BRINGS FOOD, JOBS AND ART TO HARTFORD. WE HAVE ALSO ESTABLISHED THE ADA MARIA ISASI-DIAZ JUSTICE INSTITUTE TO ADDRESS CHALLENGES SPECIFIC TO LATINX WOMEN.
