The Amplify Fund is a funder collaborative that has channeled over \$17.5 million since 2018 to support BIPOC and low-income communities to build power and to influence decisions about the places they live and work. Together with our funding partners, Amplify leads a place-based strategy and collaborates directly with movement leaders in each place (California, Missouri, Nevada, North Carolina, Pennsylvania, Puerto Rico, South Carolina, and Tennessee) to make grantmaking decisions.

Funders for a Just Economy (FJE) is a national network of funders committed to advancing the philanthropic conversation around economic justice and workplace power. This network investigates and highlights economic discrimination and disparities based on race, gender, and migration status; and how philanthropy perpetuates these disparities through its grantmaking and employment practices.

Integrated Rural Strategies Group (IRSG) is developing a shared understanding among funders at a national scale of what it takes to build community-led capacity to advance justice and equity for rural communities. Using a placebased approach, IRSG is bringing funders together to address local needs and gaps in rural organizing infrastructure and develop shared agendas to support rural organizing and justiceadvancing efforts.

Across all of NFG’s programs, we focus on lifting up community voices and place-based strategies. Our work in place builds and strengthens relationships between national grantmakers, local and regional funders, and community organizations for our long-term outcome: philanthropic assets are liberated so that BIPOC communities and low-income communities have power to self-determine.NFG’s National Convenings are currently designed for staff and board members at foundations and grantmaking organizations whose primary activity is funding racial, gender, economic, disability, and climate justice.
