THIS INCLUDED HOSTING THE 33RD EDITION OF OUR ANNUAL CONFERENCE ON AGING, WHICH DREW 600 PARTICIPANTS A RECORD FOR THE THIRD YEAR IN A ROW AS WELL AS MULTIPLE WORKGROUPS, AND PEER-TO-PEER TRAINING OF NONPROFIT PROFESSIONALS WHO PROVIDE SERVICES TO OLDER ADULTS.
