REACTION IS A YEAR-LONG EDUCATION PROGRAM DELIVERED IN SCHOOLS THAT ARE DISPROPORTIONATELY AFFECTED BY GUN VIOLENCE. SINCE 2001, NYAGV EDUC FUND HAS GUIDED STUDENTS THROUGHOUT NEW YORK CITY IN A YEAR-LONG CURRICULUM, EMPHASIZING PERSONAL AND GROUP DEVELOPMENT, MISCONCEPTIONS ABOUT GUNS AND GUN VIOLENCE, POLICY AND PROGRAMMATIC SOLUTIONS TO REDUCING GUN VIOLENCE, AND ADVOCACY SKILLS. THE PROGRAM CULMINATES WITH A GROUP TRIP TO ALBANY OR WASHINGTON, IN WHICH STUDENTS BRING THEIR CONCERNS DIRECTLY TO LAWMAKERS.
