CRIME VICTIMS AND DV (SEE SCHEDULE O):CRIME VICTIMS AND DV: EMPIRE JUSTICE LEADS THE NEW YORK CRIME VICTIMS LEGAL NETWORK, A PARTNERSHIP OF CIVIL LEGAL ORGANIZATIONS AND VICTIM ASSISTANCE PROGRAMS THAT CONNECTS VICTIMS OF CRIME WITH INFORMATION AND ASSISTANCE THROUGH ITS MULTIFACETED ONLINE TOOL (NY CRIME VICTIMS LEGAL HELP). IN 2023, OVER 22,520 PEOPLE USED THIS TOOL TO ACCESS KNOW-YOUR-RIGHTS RESOURCES AND CONNECT WITH AGENCIES WHO COULD HELP THEM.
