LAST YEAR OXFAM AND ITS PARTNERS SUCCESSFULLY EXERTED PRESSURE ON RICH COUNTRIES TO TAKE MEANINGFUL ACTION ON LOSS AND DAMAGE, RESULTING IN THE APPROVAL OF A LOSS AND DAMAGE FUND AT COP27. IN COLLABORATION WITH ALLIES, JOINT ADVOCACY EFFORTS WITH THE UNITED STATES, INCLUDING HIGH-LEVEL CEO MEETINGS WITH JOHN KERRY, ADDITIONAL ENGAGEMENTS, AND CORRESPONDENCE WITH CONGRESS, INFLUENCED A CHANGE IN THE US POSITION ON THE FUND. DIGITAL FUNDRAISING: LAST YEAR OXFAM DEEPENED ENGAGEMENT WITH ACTION FUND ACTIVISTS AND CONSTITUENTS THROUGH DIGITAL CHANNELS. IN JUNE 2022, CONGRESS PASSED AN EMERGENCY SUPPLEMENTAL SPENDING BILL THAT ALLOCATED \$5 BILLION FOR HUMANITARIAN RESPONSE. OUR CONTRIBUTIONS WERE SIGNIFICANT, INCLUDING GENERATING SUBSTANTIAL MEDIA ATTENTION AND RAISING PUBLIC AWARENESS ABOUT THE ISSUE. ADDITIONALLY, WE COLLECTED 32,739 SUPPORTER SIGNATURES FOR A PETITION TO CONGRESS, FURTHER AMPLIFYING THE CALL FOR ACTION AND DEMONSTRATING WIDESPREAD PUBLIC SUPPORT FOR THE CAUSE.

DIGITAL ADVOCACY: IN OUR PUBLIC ENGAGEMENT EFFORTS, OXFAM AMERICA COLLABORATED WITH PUBLIC CITIZEN TO LEAD A LETTER ADDRESSED TO THE US CONGRESS, URGING EMERGENCY FUNDING FOR THE GLOBAL COVID-19 RESPONSE. THE LETTER GARNERED SIGNIFICANT SUPPORT AND WAS CO-SIGNED BY MORE THAN 50 US-BASED GROUPS. THIS COLLECTIVE ADVOCACY EFFORT GAINED ATTENTION AND WAS COVERED BY PROMINENT MEDIA OUTLET THE WASHINGTON POST. ADDITIONALLY, OXFAM'S LOW WAGE MAP AND BEST STATES TO WORK INDEX (BSWI) RECEIVED WIDESPREAD MEDIA COVERAGE IN MAJOR NATIONAL OUTLETS AND ON SOCIAL MEDIA PLATFORMS. THESE TOOLS BECAME INSTRUMENTAL IN ENGAGING WITH CIVIL SOCIETY, US CONGRESS, AND THE ADMINISTRATION ON LABOR AND DOMESTIC CARE ISSUES. OXFAM ALSO CONDUCTED BRIEFINGS WITH THE DEPARTMENT OF LABOR, INCLUDING THE WOMEN'S BUREAU AND REGIONAL BUREAUS, AS WELL AS POLICY STAFF. FURTHERMORE, OXFAM'S RESEARCH AND RESOURCES BECAME A TRUSTED AND RELIABLE SOURCE, ENHANCING OUR REPUTATION IN THE LABOR AND DOMESTIC CARE SECTORS. THE DEPARTMENT OF LABOR RECOGNIZED AND UTILIZED OXFAM'S WORK AS A KEY RESOURCE IN THEIR EFFORTS.
