Our flagship, peer reviewed, Journal of Folklore and Education has 13,000 unique readers, 10 Volumes featuring global authors, and 12 member volunteer editorial board. Volume 10 (2023) featured 11 articles, 5 reviews, and a Curriculum Guide with 5 units. We accepted 68% of submissions, following peer review. Our Culture, Community, and the Classroom (CCC) program in Upstate NY supported teachers and artists in planning and implementing 16 artist residencies and published 11 teachers' CCC lessons that connect cultural knowledge to education standards.
