WE DO THIS BY FACILITATING AND PROMOTING SPAY/NEUTER AND TRAP, NEUTER AND RETURN (TNR), CONDUCTING FOSTER-BASED RESCUE AND ADOPTION FROM LOCAL SHELTERS, AND PROVIDING PET RETENTION AND REHOMING PROGRAMS. OUR INTENT IS TO STEADILY DECREASE THE INTAKE OF CATS AND KITTENS AT LOCAL SHELTERS AND TO ULTIMATELY END THE EUTHANASIA OF HEALTHY ADOPTABLE PETS IN THE COMMUNITIES WE SERVE.

CATS WERE ADOPTED FROM OUR LOCAL PETSMART STORE ADOPTION CENTER AS WELL AS THROUGH PROMOTION ON OUR INTERNET ADOPTION SITE. ALL CATS WERE ALTERED, TESTED, VACCINATED AND TREATED FOR PARASITES PRIOR TO ADOPTION. MANY OF THESE CATS CAME TO US INJURED OR ILL REQUIRING ADDITIONAL VETTING EXPENDITURES TO READY FOR ADOPTION. 689 CATS WERE TAKEN IN FROM AREA SHELTER ORGANIZATIONS. IN ADDITION, 16 CATS WERE TRANSPORTED OUT FOR AN ADOPTION EVENT SPONSORED BY OUR LOCAL SPCA. CONTRIBUTED VETERINARY SERVICES IN THE FORM OF DISCOUNTS TOTALED 6,133.
