Returning Veterans Project (RVP) is an Oregon nonprofit comprised of community-based, independent health-care practitioners who offer free and confidential services to post-9/11 war zone veterans, active service members, and their families in Oregon and Southwest Washington. Our volunteers include mental-health professionals, acupuncturists, naturopaths, chiropractors, massage therapists, and other providers of complementary health care. Under IRS Form 990 guidelines, In-kind gifts of professional services have been excluded from all other expenses and total functional expenses. Under Generally Accepted Accounting Principles Our audited financial statements records an additional \$363,743 of program services through gifts-in-kind, resulting in program services expense percentage of 78.8%. Providers include Mental Health Professionals, Acupuncturists, Naturopaths, Chiropractors, Massage Therapists, and other complementary Health Care Practitioners. In addition to the amount of program costs of \$100,697 there is an additional amount of \$298,028 of In-kind donated services which are not included under IRS Form 990 guidelines. The total amount of Network Program costs including In-Kind is \$398,725 which is recognized in our audited financial statements. Please refer to our audited financial statements.
