APPROXIMATELY 3,000 BOXES WERE DISTRIBUTED TO CLIENTS OF OUR OUTREACH CENTER. THE CAFE BREAD ROOM ALSO PROVIDES BREAD AND BAKED GOODS DAILY FOR CLIENTS TO TAKE AS THEY LEAVE THE CENTER.
