THE COMMUNITY SUPPORT PROGRAM CONTINUES TO CARE FOR THE HOMELESS, HUNGRY, AND FOOD-INSECURE RESIDENTS OF TRENTON AND MERCER COUNTY, NJ. THE PANTRY IS OPEN MONDAY-FRIDAY AND HOUSEHOLDS MAY COME ONCE PER WEEK. IN FY2023, THE PANTRY AVERAGED EACH MONTH 272 SINGLE HOUSEHOLD VISITS AND 1,157 FAMILY HOUSEHOLD VISITS, IMPACTING 4,865 CARE RECEIVERS. WE CONTINUE TO PARTNER WITH CATHOLIC CHARITIES DIOCESE OF TRENTON TO JOINTLY OPERATE THE FOOD PANTRY. ADDITIONALLY, AN AVERAGE OF 35 SENIOR CITIZEN HOUSEHOLDS ARE ENROLLED IN THE MONTHLY USDA COMMODITY SUPPLEMENTAL FOOD PROGRAM. OUR THANKSGIVING DINNER PROJECT PROVIDED ALL THE INGREDIENTS FOR A TRADITIONAL MEAL TO 850 FAMILIES AND OVER 250 FAMILIES RECEIVED TOYS AND GIFTS FOR CHRISTMAS. OTHER PROJECTS INCLUDE SPECIALTY FOOD DRIVES FOR HIGH REQUEST ITEMS SUCH AS CEREAL; OFFERING CAKE MIX, CANDLES, ETC. AS KITS FOR BIRTHDAYS; CELEBRATING HOLIDAYS SUCH AS LABOR DAY WITH HOTDOGS AND BUNS; AND HOLDING A MONTHLY NUTRITIONAL AWARENESS DAY. OUR OPERATIONS WOULD NOT BE POSSIBLE WITHOUT THE FINANCIAL AND IN-KIND GIFTS AS WELL AS VOLUNTEER SERVICE RECEIVED FROM THE GUILD MISSION MEMBERS AND THE LOCAL COMMUNITY. STAFF COORDINATED PREVENTION SERVICES FOR 13 HOUSEHOLDS NEEDING UTILITY ASSISTANCE TO PREVENT SHUT OFFS AND 30 HOUSEHOLDS WITH RENT/MORTGAGES PAYMENTS IN ARREARS.
