THE VISUAL ARTS CENTER OF NEW JERSEY'S STUDIO SCHOOL IS THE LARGEST NON-UNIVERSITY ARTS PROGRAM IN THE STATE. STUDENTS OF PRE-SCHOOL AGE TO OCTOGENARIANS ENROLL EACH SEMESTER. A RENOWNED FACULTY OF PROFESSIONAL TEACHING ARTISTS OFFER CLASSES AND WORKSHOPS IN DRAWING, PAINTING, CERAMICS, PHOTOGRAPHY, DIGITAL MEDIA, PRINTMAKING, SCULPTURE, JEWELRY DESIGN AND MORE. THE ART CENTER'S STUDIO SCHOOL CALENDAR IS DIVIDED INTO THREE TEN-WEEK SEMESTERS, FALL, WINTER AND SPRING AND A SHORTER SIX-WEEK SUMMER SEMESTER. SUMMER SEMESTER INCLUDES A CHILDREN'S ART SUMMER CAMP PROGRAM SERVING NEARLY 1,000 STUDENTS AGES 4-18.

ITS MUSEUM EXHIBITION PROGRAM PRESENTS ARTISTICALLY AND CULTURALLY DIVERSE CONTEMPORARY ART EXHIBITIONS TO OVER 8,600 VISITORS ANNUALLY. TO ADDRESS AN INCREASINGLY GLOBAL SOCIETY, THE ART CENTER FEATURES ARTISTS FROM NEAR AND FAR. MANY ARE FROM NEW JERSEY AND NEARBY NEW YORK, FROM ACROSS THE US AND FROM AROUND THE WORLD.
