MYS enrolls 400 school-age students in the greater Portland metropolitan area and SW Washington. In addition we offer a Beginning Strings Class, and introductory to advanced classes in music theory. Each season MYS holds at least 3 concerts at the performing arts center in downtown Portland and 9 concerts throughout the community.
