SUSTAINABILITY: TO INCREASE ENVIRONMENTAL ACTION LOCALLY, THE GREEN BUSINESS BOOTCAMP EQUIPPED 56 SMALL BUSINESSES WITH A PLAN AND FUNDING IN PLACE TO IMPLEMENT PROJECTS THAT WILL CONSERVE THEIR ENERGY, WATER, OR WASTE AND REDUCE OPERATIONAL COSTS. THE PROGRAM HAS SERVED THE GREATER PHOENIX AND TUCSON METRO AREAS AS WELL AS THEVERDE VALLEY, WHICH IS A RURAL AREA. AS A GREEN NONPROFIT, LOCAL FIRST SINGATURE EVENTS DIVERTED 68% OF WASTE FROM THE LANDFILL TO REUSE, COMPOST AND RECYCLE.
