OUR OPERATIONS IN THESE AREAS ARE DESIGNED AS STRATEGIES TO ACHIEVE ANNUAL OBJECTIVES AND LONG-TERM GOALS.COMMUNITY ORGANIZING AND ENGAGEMENT (COE):CLRJ'S COMMUNITY ORGANIZING AND ENGAGEMENT DEPARTMENT AIMS TO BUILD LATINA/E LEADERSHIP AND ENSURE THAT OUR POLICY PRIORITIES ARE INFORMED, SHAPED AND MOVED BY OUR COMMUNITIES.
