WE PROVIDE TBRI (TRUST BASED RELATIONAL INTERVENTION) THERAPY AND IN HOME SUPPORT, SUPPORT GROUPS, INTRODUCTION TO TBRI, AND STABILIZATION TRAINING, AS WELL AS CONTINUING EDUCATION HOURS FOR FOSTER FAMILIES.
