In 2023, EDLC worked with dozens of law firms and legal NGOs, several volunteer scientists and researchers, and numerous civil society organizations and community groups on over fifty matters in twenty-four countries. The number of individuals helped in each case ranged from one to tens of thousands, with the majority of cases being brought on behalf of communities of hundreds or thousands of individuals. In addition to other forms of assistance--including the recruitment and support of pro bono lawyers and scientists; legal analysis and briefing; and strategic guidance and support--EDLC provided funding for litigation expenses through agreements with lawyers and NGOs in fourteen countries. The objective of all of these efforts was to assist environmental defenders by helping to: 1) influence or stop development projects that threaten the health, way of life, and environment of affected communities; 2) obtain redress from corporations and governments for harms caused to communities by such projects; 3) address the drivers and impacts of climate change; and 4) safeguard the civil and political rights of environmental defenders.
