In 2018 we extended all programs and services to First Responders.

28 2023 was a good year for K9CMT. Here are a few of the more significant highlights: Our deliverables, our dogs, continue to amaze those of us who select and train them. The men, women, and children who benefit from these extraordinary gifts continue to impress us also with their commitment to and love for their dogs. We remained at what has essentially become a steady state of projects under management. At any one time there will be six to eight projects working their way through the process from socialized pup to service dog in training, and finally as finished servicer dogs. Each year an additional six to eight enter the stream. Keep in mind the gold standard against which we work. No compromises, no shortcuts. Not ever. We expect to inject another go-round of pups in 2024. Preparations are being made to kick off a K9CM Pod Cast in 2024 with focus on service dog awareness and education. As mentioned earlier, our 2250 square foot indoor training facility is complete and up and running at our operational center in Livingston.
