The mission of the San Francisco Public Press is to enrich civic life in San Francisco by delivering public-interest journalism to broad and diverse audiences through print and interactive media not supported by advertising. The San Francisco Public Press (sfpublicpress.org) is a nonprofit, noncommercial news organization that produces independent public-interest journalism about under-covered topics, with a focus on under-served audiences. Online and via community radio station KSFP-FM, we offer local investigative and solutions reporting. Coverage areas include environmental protection, housing affordability, public health, transportation safety, homeless services, digital privacy, immigration and elections. For every local election, we produce a comprehensive, multimedia nonpartisan voter guide.

The San Francisco Public Press (sfpublicpress.org) is a nonprofit, noncommercial news organization that produces independent public-interest journalism about under-covered topics, with a focus on under-served audiences. Online and on community radio station KSFP 102.5 FM, we offer local investigative and solutions reporting. Coverage areas include environmental protection, housing affordability, public health, transportation safety, homeless services, digital privacy, immigration and elections. For every local election, we produce a comprehensive, multimedia nonpartisan voter guide. (San Francisco did not hold any elections in 2023; we returned to this work in 2024.) In 2023, "Civic," our local public policy interview podcast and radio show, produced two seasons, with in-depth reporting and highly produced episodes. For "Civic," investigative reporter Sylvie Sturm and producer Liana Wilcox produced a six-part series on San Francisco's overdose crisis: Part 1 (https://www.sfpublicpress.org/san-franciscos-fatal-overdose-crisis-was-decades-in-the-making/), Part 2 (https://www.sfpublicpress.org/sf-failing-on-housing-as-overdose-solution-health-expert-says/), Part 3 (https://www.sfpublicpress.org/drug-crackdown-has-sparked-violent-turf-warfare-in-central-san-francisco-supervisor-says/), Part 4 (https://www.sfpublicpress.org/das-opposition-to-drug-diversion-programs-undermines-public-safety-say-legal-advocates/), Part 5 (https://www.sfpublicpress.org/city-officials-lack-urgency-to-prevent-overdose-deaths-say-safe-consumption-proponents/) and Part 6 (https://www.sfpublicpress.org/sf-students-sro-residents-train-to-reverse-drug-overdoses/). Wilcox also led production of episodes on a wide range of topics built around reporting by other journalists in our newsroom, some of which are described below. (See: https://www.sfpublicpress.org/civic) Throughout 2023, many of our reporters cover issues related to homelessness and housing insecurity. In January, Madison Alvarado and Yesica Prado interviewed more than two dozen people about the challenges of finding shelter in eight San Francisco neighborhoods over three days during a period marked by severe winter storms when several shelters were close to capacity. (See: https://www.sfpublicpress.org/facing-brutal-storms-homeless-people-encountered-hurdles-to-finding-shelter/) Prado also reported on Berkeley acknowledging that it was aggressive in sweeping homeless encampments and the city's promise to reform its policies (https://www.sfpublicpress.org/berkeley-apologizes-for-aggressive-homeless-encampment-sweeps-promises-reforms/). Mel Baker, our program director for KSFP, reported on ways that San Francisco used events and construction permits to justify encampment removals (https://www.sfpublicpress.org/sf-uses-events-construction-projects-to-clear-streets-ahead-of-pacific-rim-economic-summit-other-gatherings/). Alvarado also reported on San Francisco's plan for building enough housing to meet state requirements (https://www.sfpublicpress.org/plan-for-82000-homes-in-sf-moves-forward-under-pressure-from-state/), and poor conditions in public housing complexes (https://www.sfpublicpress.org/emergency-repairs-in-public-housing-complex-are-behind-schedule-as-owner-advances-redevelopment-plans/) and ongoing code violations for the companies that manage them (https://www.sfpublicpress.org/after-massive-renovations-code-violations-rise-steeply-in-subsidized-housing/). She also reported on how most calls to a hotline from people seeking shelter went unresolved because staff couldn't reach the people seeking help (https://www.sfpublicpress.org/sf-shelter-hotline-staff-could-not-reach-most-people-who-called-for-help/). She also followed development of San Francisco's reparations plan, which included recommendations to make up for harms caused by urban renewal in the 20th century (https://www.sfpublicpress.org/housing-program-to-redress-urban-renewal-could-get-boost-from-sf-reparations-plan/) and other housing policy reforms (https://www.sfpublicpress.org/without-dropping-cash-reparations-idea-sf-investigates-new-housing-reforms/) recommended by a local task force (https://www.sfpublicpress.org/sf-reparations-plan-nears-submission-but-funding-not-yet-secure/) leading up to the submission of its final report (https://www.sfpublicpress.org/new-reparations-ideas-include-senior-housing-legal-assistance-and-a-black-card-for-local-discounts/). Sylvie Sturm continued reporting on California's family court system, producing print and audio pieces on a controversial response to child abuse claims through a legal tactic called parental alienation (https://www.sfpublicpress.org/family-courts-rely-on-dubious-theory-to-dismiss-child-abuse-claims/) and forced reunification camps (https://www.sfpublicpress.org/childrens-violent-removal-from-santa-cruz-home-raises-calls-to-end-reunification-camps/). She also produced additional text stories on the overdose crisis to supplement her six-part "Civic" series with reporting on local efforts to introduce safe consumption sites (https://www.sfpublicpress.org/with-overdose-deaths-surging-critics-hide-city-state-for-curbing-safe-consumption-centers/), law enforcement crackdowns on open air drug use and sales (https://www.sfpublicpress.org/military-style-drug-war-in-tenderloin-sparks-fears-that-more-drug-users-could-overdose/), and how 2023 was San Francisco's deadliest year on record for drug overdoses (https://www.sfpublicpress.org/2023-is-san-franciscos-deadliest-year-on-record-for-drug-overdoses/). Freelance reporter Viji Sundaram followed up on her previous reporting on California's family courts and coercive control laws in relation to custody cases (https://www.sfpublicpress.org/state-bill-to-keep-children-safe-in-custody-battles-passes-first-hurdle/) and how a court reporter shortage is limiting access to justice in domestic violence cases (https://www.sfpublicpress.org/californias-court-reporter-shortage-limits-access-to-justice-in-domestic-violence-cases/). Freelance reporter Kristi Coale produced an in-depth, data-driven investigation on how developers building housing on Treasure Island are not accounting for climate science updates showing that sea level rise could threaten the new neighborhood much sooner than anticipated in original designs (https://www.sfpublicpress.org/promising-to-prevent-floods-at-treasure-island-builders-downplay-risk-of-sea-rise/). Freelance reporter Seth Rosenfeld continued to report on the California Public Utilities Commission's regulation of - and failure to track consistent data on - the ride-hailing industry (https://www.sfpublicpress.org/local-planners-say-state-failed-to-track-safety-incidents-on-uber-and-lyft/). Freelance reporter Ambika Kandasamy produced a series about the health risks older adults face related to climate change-driven weather disasters. She examined the physical and mental health effects of these events on older people and explored how such challenges are unfolding in San Francisco's Chinatown. The San Francisco Public Press served in a very limited capacity as fiscal sponsor for Mission Local. The following details are repeated on Schedule I, Part I, Line 2: From 2018 through 2022, we monitored the use of grant funds by Mission Local through regular conversations - at least monthly - with Lydia Chavez, executive director of Mission Local. In 2018 we began fiscally sponsoring Mission Local, a news organization focusing on San Francisco's Mission District. Mission Local's journalistic work is in a similar educational vein as the Public Press's and is aligned with our charitable purpose. Mission Local, a legally incorporated entity, filed for and received its own 501c3 in late 2022, after which the organization began receiving and managing its own grants and donations directly. In 2023, the Public Press received a small number of donations intended to support the work of Mission Local from donors who did not realize that the organization had received its own 501c3 status. All donations received by the Public Press and distributed to Mission Local in 2023 were used to pay staff salaries and freelance journalists.
