BEYOND HUNGER WORKS TO END HUNGER THROUGH DISTRIBUTING FOOD TO THOSE IN IMMEDIATE NEED WHILE WORKING TOWARDS MORE PERMANENT FOOD SECURITY THROUGH COMMUNITY ACTION AND POLICY CHANGE. IN FISCAL YEAR 2023, BEYOND HUNGER DISTRIBUTED OVER 1.2 MILLION POUNDS OF FOOD OR THE EQUIVALENT OF 1 MILLION MEALS. FOOD PANTRY AND HOME DELIVERY PROGRAMS BOTH EXPANDED TO MEET INCREASED NEED. THE POP-UP FOOD PANTRY "DESPENSA" CONTINUED TO SERVE AN IMMIGRANT POPULATION WITH CULTURALLY FAMILIAR FOODS.
