FOLLOWING OUR 2023 VICTORIES, ACE HAS POSITIONED ITSELF AS A LEADER IN ECONOMIC JUSTICE ORGANIZING, VOTER REGISTRATION PROGRAMMING, AND IMMIGRATION. ACE REGISTERED 10,000 VOTERS ACROSS THE STATE OF ARIZONA.
