IN 2023, HOT OPERATED 4 REGIONAL OPEN MAPPING HUBS IN LATIN AMERICA & THE CARIBBEAN, WEST & NORTHERN AFRICA, ASIA PACIFIC, AND EASTERN & SOUTHERN AFRICA. THESE TEAMS TOGETHER SUPPORTED OVER 100 COMMUNITIES ACROSS MORE THAN 60 COUNTRIES WORKING WITH THOUSANDS OF LOCAL COMMUNITY MEMBERS.
