THIS PAST YEAR WE SERVED INDIVIDUALS FROM 28 COUNTIES (OUT OF A TOTAL OF 33) IN NEW MEXICO AND PROVIDED DIRECT REPRESENTATION, ADVICE, BRIEF SERVICES, NAVIGATION, LEGAL INFORMATION AND REFERRAL TO 5,757 INDIVIDUALS. TO EXPAND ACCESS IN REMOTE AREAS WE HAVE DEVELOPED A REMOTE LEGAL SERVICE INFRASTRUCTURE TO PROVIDE BRIEF SERVICES SUPPORT FOR INDIVIDUALS APPLYING FOR CITIZENSHIP, GREEN CARD RENEWAL, AND WORK PERMIT RENEWAL.
