Our programs include harm reduction outreach, where staff create opportunities for meaningful change through participant-driven, holistic goal setting while assisting with practical issues like transportation, insurance, obtaining vital docs, or finding stable housing. HIV & Hepatitis C testers conduct community -based testing, education and linkage to care. We ensure that safety supplies are available to people who use drugs and those who love them throughout AZ. Our syringe service program provides safe disposal of used - and access to new - syringes as well as naloxone, fentanyl test strips, wound care and hygiene supplies via street outreach, fixed sites, home delivery and harm reduction by mail.
