THIS LEGAL ASSISTANCE INCLUDES DIRECT LEGAL REPRESENTATION FOR IMMIGRANT SURVIVORS, AS WELL AS THE OPERATION OF ORIENTATION PROGRAMS AND INFORMATION SESSIONS FOR IMMIGRANTS WHO MUST REPRESENT THEMSELVES IN IMMIGRATION COURT. ICWC SPECIALIZES IN AFFIRMATIVE IMMIGRATION REMEDIES SUCH AS U VISAS, AND VIOLENCE AGAINST WOMEN ACT VAWA PETITIONS. ICWC ALSO HAS A STRONG FOCUS ON PROVIDING ASSISTANCE FOR UNACCOMPANIED CHILDREN INCLUDING SPECIAL IMMIGRANT JUVENILE STATUS SIJS AND ASYLUM SERVICES.
