OUR STUDENTS ATTEND SCHOOL DAILY FROM 800 A.M. UNTIL 500 P.M. EACH DAY. THE FOLLOWING IS A BRIEF OUTLINE OF OUR EXTENDED DAY EACH CONTENT-AREA CLASS IS SCHEDULED FOR 60 TO 90 MINUTES EACH DAY. OUR DAILY AFTERNOON STUDY HALL IS STRUCTURED TIME FOR STUDENTS TO BEGIN THEIR HOME ASSIGNMENTS AND TO WORK WITH TEACHERS, IF NEEDED, FOR ADDITIONAL HELP.
