WE SUPPORTED FGM-RELATED LEGISLATION IN WASHINGTON, D.C., AND CONTINUED ADVOCATING IN THE 9 STATES THAT STILL LACK FGM BANS. ADDITIONALLY, AHA SUPPORTED LEGISLATION IN CALIFORNIA TO IMPLEMENT FGM PREVENTION EDUCATION. AHA ALSO PUBLISHED A REPORT TITLED FEMALE GENITAL MUTILATION IN THE U.S., THE MOST COMPREHENSIVE REPORT ON DOMESTIC OCCURRENCE TO DATE. CHILD MARRIAGE LEGISLATION - AHA FOUNDATION SUCCESSFULLY ADVOCATED FOR CHILD MARRIAGE BANS IN VT, CT, AND MI, RAISING THE TOTAL NUMBER OF STATES THAT HAVE ENDED CHILD MARRIAGE TO 10.
