4a (Code:) (Expenses \$ 175,000 including grants of \$) (Revenue \$) Special Women Initiative with WBDGUnited4Change Center (U4C) and Womens Declaration International USA (WDI), located at 65 Greene St, Catskill, NY 12414, share a commitment to promoting the welfare of women and girls. U4C successfully secured funding to facilitate and widely distribute public education on threats to the well-being of women and girls. Recognizing that U4C may not have the internal capacity to effectively distribute these public education initiatives, WDI, with its expertise, has agreed to assist. This partnership has enabled U4C to meet its grant commitment to deliver public education focused on the interests of women and girls in the United States. As a result, U4C has regranted funds to WDI for this specific purpose.

4b (Code:) (Expenses \$ 95,760 including grants of \$) (Revenue \$) HUMANITARIAN PROGRAMUkraineU4C provided critically needed support to victims of war in Ukraine through an innovative partnership with the private sector, facilitating humanitarian aid to finance initiatives by volunteers who are bravely delivering aid to remote areas not typically covered by large humanitarian aid channels. The goal of this Humanitarian Fund is to provide supplies for war victims fundamental needs: access to healthcare, shelter, food, education, clean water and electricity/heat and post-trauma support.

The program offered a comprehensive curriculum across more than 20 sessions, emphasizing education in micro-entrepreneurship, practical business planning, creativity, innovation, professional mentoring, and networking. This initiative not only aimed to furnish these women with the necessary knowledge and skills but also to foster a sense of resilience and community among them.

As an integral component of the expansive Ampara Project, the goal is to equip homes with state-of-the-art clean water infrastructure, thereby granting approximately 150 indigenous villagers access to potable water for the very first time. The endeavor encompasses the establishment of water sinks, reservoirs, and advanced purification mechanisms. Moreover, it includes comprehensive training programs for 500 villagers, designed to foster long-term sustainability and self-reliance within these communities.

Our services added value and mobilized community members socially, culturally, environmentally, and economically to 9 aboriginal communities in northern Argentina through the empowerment of 22 young people who live and work in these communities.

During this follow-up, U4C offered substantial support to these women entrepreneurs, promoting their products and further enhancing their business ventures.
