VET CLINIC - THE MONROE COUNTY HUMANE ASSOCIATION (MCHA) HAS BEEN DEDICATED TO ANIMAL WELFARE SINCE 1956, PROVIDING ACCESSIBLE VETERINARY SERVICES, ANIMAL CARE RESOURCES, AND HUMANE EDUCATION. AS A LEADING ADVOCATE IN OUR COMMUNITY, MCHA CONTINUOUSLY CHAMPIONS THE RIGHTS OF ANIMALS. THROUGH THE NONPROFIT VETERINARY CLINIC, MCHA PROVIDED DIRECT VETERINARY SERVICES TO MORE THAN 2,743 PATIENTS AT 8,575 PATIENT VISITS SEEKING CARE FOR WELLNESS, INJURY AND SURGERY SERVICES. MCHA PROVIDED 115,414 IN SUBSIDIZED CARE TO 2,306 OF THESE PETS OF WHICH THE FAMILIES LIVE AT OR BELOW 150% OF THE FEDERAL POVERTY LEVEL.
