THROUGH THIS EFFORT, OUTREACH WORKERS AND CASE MANAGERS ARE CONNECTING WITH INDIVIDUALS LIKELY TO BE PERPETRATORS OR VICTIMS OF SHOOTINGS AND HELP THEM FIND ALTERNATIVES TO VIOLENCE.- PEOPLE ARE REFERRED TO JOB AND EDUCATIONAL OPPORTUNITIES AND ARE ENGAGED IN COMMUNITY IMPROVEMENT EFFORTS.
