IN GUATEMALA, HRI CONTINUED TO ESTABLISH PROGRAMMING IN THE WESTERN HIGHLANDS OF THE COUNTRY, A LARGELY INDIGENOUS REGION WITH SIGNIFICANT LEVELS OF POVERTY AND EXTREME HUNGER AND MALNUTRITION, PARTICULARLY AMONG CHILDREN. HRI CONTINUED TO ADAPT AND EXPAND OUR PROGRAMS TO MEET GROWING NEEDS WITH LONG-TERM, SUSTAINABLE RESPONSES TO THE DAILY STRUGGLES OF VULNERABLE CHILDREN, WOMEN, AND FAMILIES. IN THE SOUTHERN DEPARTMENT OF SANTA ROSA, HRI CONTINUED TO PROVIDE A NUTRITIOUS BREAKFAST PROGRAM TO HUNDREDS OF CHILDREN ATTENDING THREE SCHOOLS. THROUGH THIS PROGRAM, SCHOOL ATTENDANCE REACHED AN INCREDIBLE 94 AND NEARLY ALL THE STUDENTS EXCELLED ACADEMICALLY THROUGH THE YEAR. THIS PROGRAM ONCE AGAIN DEMONSTRATES THE VALUE OF A GOOD BREAKFAST BEFORE SCHOOL. THE SECURITY SITUATION IN HAITI CONTINUED TO DETERIORATE IN 2023 WITH RAMPANT GANG VIOLENCE, DAILY KIDNAPPINGS, AND BLOCKED NEIGHBORHOODS.
